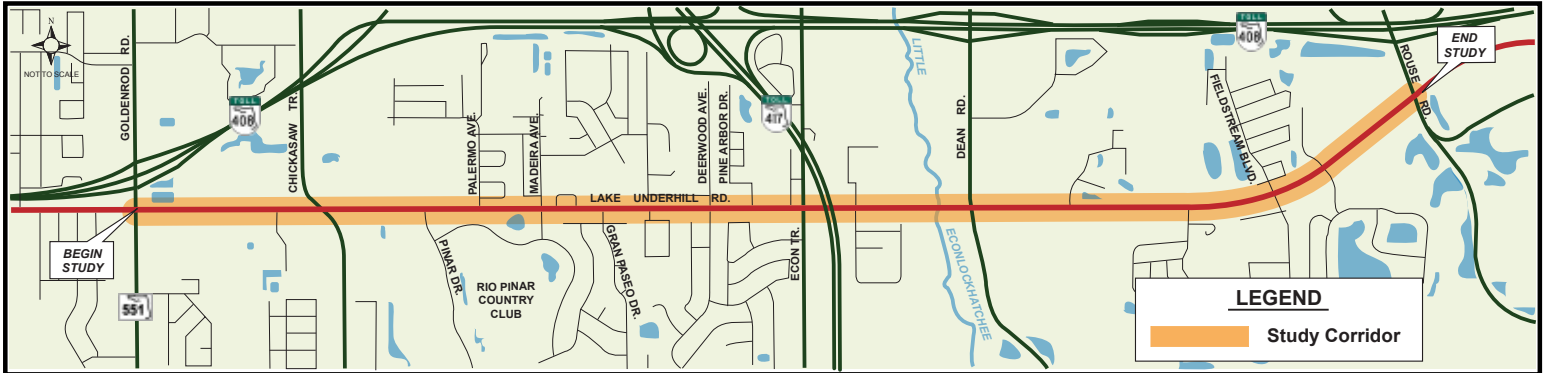

LAKE UNDERHILL ROAD RCA STUDY

Orange County is conducting a Roadway Conceptual Analysis (RCA) Study for the planned improvement of Lake Underhill Road from just east of Goldenrod Road to Rouse Road. The RCA Study is Orange County's detailed project development process to study the engineering, social, and environmental impacts of potential roadway improvements. The intent of this study is to identify the most appropriate improvement(s) for this segment of Lake Underhill Road.

In addition to roadway widening, the study is evaluating several elements including drainage improvements, existing and future traffic volumes, the addition of sidewalks, bicycle lanes, bus stop improvements, roadway lighting, landscape upgrades and other safety enhancements.

ORANGE COUNTY PUBLIC HEARING - AUGUST 3, 2010

The study team for the Lake Underhill Road Roadway Conceptual Analysis (RCA) Study will present the conclusions and recommendations of the RCA Study at a Public Hearing before the Orange County Board of County Commissioners (BCC) on **Tuesday, August 3, 2010. The Hearing is scheduled to begin at 9:00 am and will be held at the Orange County Administration Center located at 201 South Rosalind Avenue, Orlando.**

There will be an opportunity for public input following a formal presentation by the study team. All interested persons are invited to attend and be heard at this Hearing. If the BCC approves the RCA Study, as funds become available, the project will move forward into the design phase, followed by right-of-way acquisition and construction.

Any person wishing to appeal any decision made by the BCC at this Hearing will need a record of the proceedings. For that purpose, such persons may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based.
